
#### **ACKNOWLEDGEMENTS**

March of Dimes (MOD) convened the Mom and Baby Action Network (M-BAN) Summit (the Summit): Igniting Impact Together: Nurturing Collaborative Solutions, from June 9-10, 2024 in Chicago, IL at the Marriot Marquis. The national Summit was designed to convene birth equity champions, community partners, philanthropists, and advocates to learn, celebrate, be inspired, and act to advance health equity in maternal and infant health. Attendees worked collaboratively to identify solutions to address and improve systems that exacerbate inequities in maternal and infant health (MIH) outcomes and how these solutions could lead to more equitable outcomes.

Table 1 displays the Summit attendees, which included 308 in-person community and peer partner organizations, over 120 philanthropic representatives joining the Birth Equity Funders Summit, which was held in conjunction with the M-BAN Summit, and more than 110 speakers, poster presenters, workshop facilitators and moderators.

Of the Summit participants who completed the evaluation survey, 21% had also attended the 2022 M-BAN Summit, with more than 70% of participants joining us for the first time at the 2024 Summit. M-BAN was proud to support more than 50 community members to join and share their valuable lived experience and perspectives, further enriching the peer-to-peer learning experience that unfolded at the Summit.

This brief provides an overview of the Summit's highlights and content based on the five strategies in the National Equity Framework, and key takeaways from strategic workshop discussions and feedback from attendees. The Summit included 46 concurrent sessions and 3 skills-based workshops with over 50 presentations, networking opportunities, a live podcast recording, abundant nourishment and refreshments, and a networking reception featuring a film screening and live Q&A with the director. March of Dimes is grateful for the generous funding support and thought partnership from the Centers for Disease Control and Prevention Division of Reproductive Health, CVS Health Foundation and CareSource, which made the Summit possible. Finally, March of Dimes was pleased to co-host the <u>Birth Equity Funders Summit</u> held June 11 and 12th following the M-BAN Summit.

#### **BACKGROUND**

In 2016, March of Dimes (MOD) launched its Prematurity Collaborative to engage a broad cross section of national experts to address persistent and widening racial disparities in preterm birth by achieving equity and demonstrated improvements in preterm birth. The Mom and Baby Action Network (M-BAN) evolved from the Prematurity Collaborative to continue the work of advancing the implementation of policies, strategies, and services to improve equity and outcomes for maternal and infant health. M-BAN is a national action-oriented coalition of cross-sector partners leading broad changes in policy, research, funding, and systems to address inequities in maternal and infant health. March of Dimes serves as the backbone organization for M-BAN, providing technical assistance, guidance, training, tools, resources, and communication platforms to effectively connect partners and accelerate collective action.

M-BAN aims to mobilize partners at the national and community level to improve the health of families to ensure that "All people are healthy before, during, and after pregnancy, and if they give birth, they have healthy outcomes."

This work is guided by the five strategies in the <u>National Equity Framework</u> (explore the <u>NEF Guide</u> <u>here</u>):

- Dismantling racism and addressing unequal treatment through transforming the systems and policies that exacerbate health disparities for moms and babies.
- Increasing access to high quality healthcare by improving gaps in access to care for moms, babies, and families.
- Promoting environmental justice by addressing toxic exposures and climate change threats to create a healthy tomorrow for families.
- Advancing economic opportunity through disrupting lifelong economic insecurity and growing economic mobility to improve the health of moms, babies, and families.
- Building safe and connected communities by addressing facets of community life and support systems that impact the health of families.

#### **BACKGROUND**

In 2022, we hosted our first in-person event as the Mom and Baby Action Network; a hybrid National Summit in Atlanta, Georgia where 308 people gathered in-person and 149 virtual attendees joined us online to share, network and learn around the theme: Birthing Equitable Communities. These five strategies were the foundation of the Summit, and helped guide key discussions, strategize insightful solutions, and map out next steps to advancing maternal and infant health equity nationally.

Building on the momentum from our past events as well as the engagement and growth of our membership in the years between, the 2024 Summit was the natural progression of M-BAN's efforts to convene key stakeholders in the field. This summit brief highlights the meaningful presentations, working sessions, networking opportunities, strategies, and action that took place at the Summit that will contribute to accelerating investments and aligning resources, partners, and efforts needed to improve equitable health outcomes for moms and babies.

#### **SUMMIT HIGHLIGHTS**

The M-BAN Summit offered maternal and child health stakeholders a chance to learn from keynote speakers, panels, community initiatives, and volunteer efforts. Experts and leaders shared their work to advance equity in maternal and infant health (MIH) in the U.S., focusing on collaborative, proven strategies from the National Equity Framework. Insights from the Summit highlighted the importance of working in collaboration, addressing social drivers of health, and continuous education to positively impact equitable maternal health outcomes.

The event saw increased engagement on March of Dimes social media, interaction with M-BAN's tools and resources, and a rise in M-BAN memberships.

- From June 10-17, there were a total of 7 posts published across Instagram, LinkedIn and X (Twitter) to recap the 2024 Mom and Baby Action Summit, resulting in 6,848 impressions, 988 engagements, and an impressive engagement rate by reach (ERR) of 14.43% led by two LinkedIn posts that garnered an average 21.49% ERR.
- From June 10-17, #IgnitingImpactTogether hashtag was used 19 times across Facebook, Instagram and X (Twitter), and the #MBANSummit hashtag was used 10 times across Instagram and X (Twitter).
- The NEF Guide was downloaded 47 times.
- The Igniting Impact Together website traffic included 653 views from 339 users.
- Our Low Dose Aspring campaign QR code was scanned 25 times.



#### **SUMMIT HIGHLIGHTS**

#### The program included the following highlights:

- A graphic sketch artist provided live drawings of selected sessions, adding a creative touch to the Summit. The Sketch Effect's graphic sketch artist attended four sessions including the opening plenary, Healthy Chicago; Green Cars for Kids: Tackling the Maternal Health Crisis & Climate Crisis; Following the Mother's Lead: Improving Maternal Health through Access, Capacity and Education and our keynote address by Kimberly Seals Allers: Birth Without Bias; Centering Lived Experience to Advance Maternal Care.
- We hosted an interactive art experience by Ashley January, whose artwork, live videos, and staff were set up in the main event lobby throughout the entire function, creating an immersive and moving experience for participants.
- A live podcast experience was hosted by Kimberly Seals Allers, founder of the Irth App and creator of the Birthright podcast. Dedicated to sharing stories of black birthing joys, Seals Allers invited a Chicago mother onto the stage to share her experience navigating the maternal healthcare world, and ultimately finding a trusted care provider who helped her have a positive birth experience and a healthy baby.



#### **SUMMIT HIGHLIGHTS**

- Live screening of Aftershock and Q&A with director Tonya Lewis Lee. Beginning with an evening
  networking reception with refreshments, participants watched the powerful documentary that
  sheds light on tragic and preventable losses of two women during their birthing experiences.
  We were fortunate that Lewis Lee, the film's director and producer, as well as March of Dimes
  trustee and maternal health advocate, was able to join us on stage for a live Q&A. Participants
  were able to share their thoughts, experiences, and ask questions that grounded the powerful
  evening in hope.
- Breakfast networking and poster presentations. On the final morning of the Summit, poster
  presentations were set up in the dining room and participants had several hours to network,
  view posters, speak with poster presenters, and share learnings and ideas. With over 16 posters,
  participants were exposed to a wide variety of innovative solutions in maternal and infant health
  and started the day with fresh energy and enthusiasm.
- Closing keynote address featuring Kimberly Seals Allers presenting Birth Without Bias: Centering
  Lived Experience to Advance Maternal Care. The closing session, drawing upon findings from
  Allers' Birthright podcast, left participants feeling empowered and ready to tackle challenges
  such as improving healthcare access and building supportive communities, reflecting the
  Summit's focus on solutions, inspiration, and shared learning.

#### **EVENT CONTENT OVERVIEW**

The M-BAN Summit was guided by the five strategies outlined in the National Equity Framework. Presentations and discussion groups concentrated on how current work in maternal and infant health (MIH) intersects with each of these strategies and how collaborative efforts are integral to advancing MIH equity. Topics addressed during the Summit spanned the framework's five strategies, exploring approaches for maternal and child health practitioners, legislative and policy improvements, and enhanced financial and community support. The Summit also integrated cross-cutting themes, emphasizing key concepts and practices that can expedite progress toward achieving equity in maternal and infant health. For instance, the opening session, Healthy Chicago, featured a panel of key stakeholders from Chicago, discussing collaborative solutions that are being advanced locally and across the state of Illinois for MIH equity.



Moderated by our MBAN NAC Co-Chair Sue Kendig, the panel included midwife Star August from the Black Midwifery Collective, Arden Handler, Professor at the UIC School of Public Health, Tayo Mbande from the Chicago Birthworks Collective, and Elizabeth Gonzalez from EverThrive IL.

The M-BAN Summit worked with community and peer partner organizations to identify aligned ways to continue to combat the systematic issues within the maternal and child healthcare systems to accelerate equitable improvements to quality of and access to healthcare and resources for all women. From empowering Labor and Delivery nurses to address obstetric violence, to scaling up the Safer Childbirth Cities Initiative, collaborative solutions to collective challenges were highlighted through concurrent sessions, workshops and poster presentations. Presenters highlighted innovative ideas around building programs to train college students as doulas, growing the black midwifery workforce, activating dads to support maternal and infant health, revitalizing indigenous birth workers, and fostering doulas as environmental justice agents.

#### **EVENT CONTENT OVERVIEW**

The packed agenda included a workshop on self-measured blood pressure programs, the cocreation of a birth equity action map and strategies for applying to and accessing funding opportunities for community-based organizations to reach sustainability. There were also sessions devoted to intersections of the Network's strategies including discussion of using green cars for kids to fight climate change while helping people access healthcare, supporting birthing families during emergencies, leveraging community wisdom to shift power dynamics in data collection, and collaborations for equitable Medicaid benefits.

Slides from individual sessions as well as posters are linked in the agenda found in the Appendix where possible. In addition, the M-BAN supported the planning and execution of the Birth Equity Funder's Summit, a related event for philanthropists that took place at the same venue immediately following the M-BAN National Summit.

#### **PARTICIPANT INSIGHTS**

The M-BAN Summit collected participants' insights throughout the course of the Summit to gather feedback and information pertaining to key topics discussed. A post-Summit survey was disseminated to all 308 participants resulting in a response rate of 24% (75 responses).

Based on overall feedback, Summit participants were inspired by the 2024 M-BAN Summit and felt attending was a worthwhile experience.



#### **ACTION COMMITMENTS**



Participants were asked to commit to taking action following the Summit. Here is a selection of relevant resulting action commitments:

- Attendees plan to connect and collaborate on future work with new connections they made with individuals and organizations during the Summit.
- Attendees plan to enhance/increase access to group prenatal care.
- Attendees plan to replicate/amplify projects they learned about at the Summit one example is a desire to replicate the work of The State of Black Arizona in their own state.
- Attendees made a commitment to share knowledge gained during the summit with their colleagues and local partners.
- Attendees made a commitment to join MBAN, and continue to advance the collective work and best practices in their own organizations and local landscape.
- Attendees made a commitment to advocate for policies that support MIH equity and data equity.
- There was a collective commitment to improve connections and convene cross-sector partners at the local, state and national level.

#### **EVALUATION DATA**

As part of the M-BAN Summit's conclusion, participants were invited to participate in a live Mentimeter poll to assess participants' thoughts on next steps and ways they could bring action directly to their communities. Participants stated they were most equipped to act on 1) Increasing Access to Quality Healthcare, and 2) Building Safe and Connected Communities, followed by 3) Dismantling Racism and Addressing Unequal Treatment.

Participants felt they were most prepared to work on these strategies because they had access to the following resources, tools, information, and partnerships:

- Local collaboratives and coalitions
- Toolkits
- Examples from states implementing solutions
- Organizational mission and goals aligned with strategy
- · Connections and influence
- · Current skills and capacity align
- Community and stakeholder interest and buy-in

Conversely, participants felt least equipped to act on 1) Promoting Environmental Justice and 2) Economic Opportunity. The reasons shared include:

- Lack of funding
- Lack of education on the intersection of these topics and maternal and infant health equity
- · Lack of political will
- · Systemic barriers feel too big
- Lack of organizational support or buy-in, not aligned with mission/goals
- Lack of training and resources
- Need additional data





#### CONCLUSION

Participants were also asked to share how they felt at the conclusion of the Summit. Participants expressed feeling connected, energized, inspired, challenged, grateful, empowered, and committed are just a few of the words expressed (see image below) as the Summit provided them with the ability to build and/or strengthen connections, created a safe space for many, and reenergized many in the MIH field feeling burned out.



The M-BAN Summit was a resounding success, and MOD will continue to work closely with partners and stakeholders to advance equitable and positive health outcomes for all mothers, babies, and their families. Attendees had the opportunity to engage with a range of activities, including presentations, workgroup sessions, a live podcast recording, a documentary screening, and a Q&A with renowned filmmaker Tonya Lewis Lee. Most notably, participants left feeling inspired and motivated by the meaningful connections they made. The Summit's impact will drive the necessary actions to promote and implement changes in maternal and infant health across the U.S. The Mom and Baby Action Network and our partners nationwide are eager to further strengthen and expand the national movement as a leading force in advancing maternal and infant health equity.
